2019-2020 PRE-K 4 ENROLLMENT

The **2019-2020** Pre-K 4 Enrollment Applications will be available for pick-up on Monday, April 15, through Thursday, April 18, at the Board of Education Office located at 26 North Main St, Miami, OK. Miami Public Schools will exhaust every effort to accommodate all Pre- K 4 students that have enrolled.

Your child must be 4 years of age by September 1, 2019, to be eligible for enrollment.

Enrollment will be conducted at the Board of Education Office on the following date and time:

Pre-K

Date: Monday, April 22

Time: 8:00 am – 4:00 pm

The Parent/Guardian must submit proper documents and fill out all paperwork required to complete enrollment into Pre-K.

Required documents needed for enrollment are as follows:

All students must have proof of residency (mortgage document, lease agreement, rent receipt, etc., AND also a current copy of an electric, gas or water bill reflecting the student’s address)

Birth Verification

Up- to- date Immunization Record

Student’s and or/Parent’s Certified Degree of Indian Blood (CDIB Card) if applicable

Parent Photo ID

Court ordered documentation regarding custody and/or guardianship (if applicable)

ALL REQUIREMENTS MUST BE MET BEFORE STUDENT’S ENROLLMENT IS COMPLETE

STUDENT’S NEED NOT BE PRESENT FOR ENROLLMENT

Transportation is not provided for Pre-K 4 students.

2019-2020 Kindergarten Enrollment



The **2019-2020** Kindergarten Enrollment Applications will be available at the Board of Education Office located at 26 North Main Street on **Monday, April 15, through Thursday, April 18**. In order for enrollment into kindergarten to be complete, the Parent/Guardian will need to submit the proper required documents and fill out all paper work that is needed.

Enrollment will be conducted at the Board of Education Office on the following dates and times:

Tuesday, April 23 - 8:00 am - 4:00 pm

Wednesday, April 24 - 8:00 am - 4:00 pm

Thursday, April 25 - 8:00 am - 4:00 pm

Your child must be 5 years of age on or before September 1, 2019, to be eligible for enrollment.

STUDENT'S NEED **NOT** BE PRESENT FOR ENROLLMENT

Pre-K 4 students who attend **Wilson Elementary** and **Washington Elementary** will not have to enroll for Kindergarten at this time. These students will have a pre-enrollment card sent home with them during our **district pre-enrollment period**.

DOCUMENTS REQUIRED FOR ENROLLMENT

1. Two (2) Proofs of residency are required. The following documents will be accepted:

One (1) Current, original Electric, Gas, or Water bill reflecting the service address

AND

A **Current** mortgage document, a **Current** lease agreement or a **Current** rent receipt

The district will not accept driver's licenses, telephone or cable bills, checks, or pieces of mail as proof of residence.

2. Birth Certificate

(Kindergarten students must be five years of age on or before **September 1, 2019**)

3. Immunization Record (Oklahoma State Requirements)

4. Student's and/or Parent's Certified Degree of Indian Blood (CDIB Card) if applicable

5. Parent/Guardian Photo ID

6. Court ordered documentation regarding custody and/or guardianship (if applicable)
